Priority 2	To provide CPD with a focus on more able pupils (staff meetings/ Inset) in writing and maths & further individualise CPD plans for teachers.
	Ensure disadvantaged pupils entering Year 1 are challenged to enable them to reach greater depth by the end of KS1 in reading, writing & maths
